

## CTHS 2023 MIXED SALE DEADLINES

**Sale Date – Wednesday, October 18<sup>th</sup>, 2023 at 2:00 pm**

### Key Dates:

<b>October 1<sup>st</sup></b>	Deadline to advise CTHS that Consignors will not require stall cards. Stall cards will be provided at a charge of (\$25/each) unless otherwise notified.
<b>October 11<sup>th</sup></b>	Registration certificates for all horses (except those weanlings not yet registered which require copy of the foal registration application) must be submitted to the Sales Office. A \$100 penalty per horse will be assessed after this date. Note: On the sale of weanlings no proceeds will be release without digital registration papers. Stallion Service Certificates and Original Coggins (the coggins should not be dated earlier than June 15 <sup>th</sup> , 2023).
<b>October 14<sup>th</sup></b>	Pregnancy certificates for broodmares and “clean and sound” certificates for fillies 3 years old and up being sold as broodmare prospects <b>must be completed no more than 10 days prior to the day of the sale and must be in the Sales Office within 5 days of the sale.</b>
<b>October 16 – 17<sup>th</sup></b>	Horses may commence shipping in to the sales grounds on Monday, October 16 <sup>th</sup> at 12:00 noon. <b>All horses must be on the grounds and ready to show no later than 10:00 am Tuesday, October 17<sup>th</sup>.</b> The CTHS will have stalls bedded down upon your arrival.
<b>October 18<sup>th</sup></b>	<b>Sale Day</b> – all horses entered will be sold on October 18 <sup>th</sup> . We will be selling entries in the following order: <b>Horses of Racing Age, Yearlings, Broodmares &amp; Weanlings. Supplemental entries will be sold in hip number order at the end of the catalogued entries.</b>
<b>Important Notices</b>	<u>Selling of Aged Broodmares:</u> SITA members have adopted rules regarding the sale of Aged Broodmares. Entries will not be accepted for broodmares which are 1) 18 years or older and which are not in foal at the time of entry OR 2) Have not been in foal for 3 consecutive years, including in the year in question.
	<u>Exogenous Anabolic Steroid Testing:</u> All Consignors warrant that any weanlings or yearlings entered in this Sale shall not have been administered any exogenous anabolic steroids within 45 days of the sale date.
	Consignors are to make sure that their horses have hay and water from the fall of the hammer until noon the next day. If horses have not been picked up by that time, please notify the Sales Office.
	Horses passing through the sale on Wednesday, October 18 <sup>th</sup> can be shipped out at the conclusion of the sale. Vehicles will not be allowed in the sales site during the Sale. All horses that are not removed by <b>Friday, October 20<sup>th</sup> at 12 noon</b> will be levied a \$100 fee per horse.
<b>E.V.A.'s</b>	Entries in this sale are not required to file an E.V.A. test with us but we are highly recommending this test be completed. A list of all entries tested will be made available in the sales office for potential buyer’s review.
<b>Vaccination Policy</b>	All horses, <b>excluding Broodmares</b> , shipping into Woodbine must have current vaccinations for EHV1/Influenza in addition to the mandatory Coggins.  EHV1/Influenza vaccines must be administered to a horse no less than 14 days and no longer than 90 days from entry date to the Woodbine Racetrack property. Other vaccinations recommended by veterinarians in Ontario must be up to date.  Proof of vaccinations in 2023 must be provided prior to shipping onto the sales site in the form of either an invoice from your vet on their letterhead or a signed veterinary certificate.

**Consignor & Agent Code of Conduct:**

<b>Horse's Condition</b>	When consigning a horse to any CTHS sale you have signed a contract that includes an agreement on your horse's condition. The CTHS would like you to add to these by stipulating that the horse's health and appearance are just as important. It is imperative that the health and physical condition of the horse upon its arrival for the sale is beyond reproach. In the event that the CTHS sale veterinarian deems any horses not to be fit for sale, the CTHS will at its discretion request the horse(s) be removed from the sales site immediately.
<b>Selling Protocols</b> <b>Industry standards that the CTHS expects to be maintained as per</b>	All horses selling in our sales must be presented and sold with a new leather halter.
	The professionalism of each individual Consignment does affect buyer's perspectives on their horses being offered for sale. It is with this that we ask that your areas are kept clean and that the horses are presented to potential buyers as professionally as possible. This includes such things as displays, attire, experienced handlers, etc.
	Consignors must make every effort possible, when showing horses, to make the sales grounds as safe as possible for prospective buyers.
	Consignors are not to remove their sale signage and displays until after the conclusion of the sale.
